TOPIC:

Commercial Setline Fishing Season in the John Day Pool

ACTION REQUESTED:

Open the Setline Fishery in the John Day Pool

FORMAL ACTION TAKEN: At the present time, there are 83 harvestable sturgeon available in the John Day Pool of zone 6 of the Columbia River. This fishery will provide needed fishing opportunity while also protecting the sturgeon resource. Therefore the F&W Committee authorizes a commercial sturgeon setline season in the John Day Pool from 6am Monday December 18 to 6 pm Saturday December 30, 2017. The fishery may be closed by emergency regulation if the sturgeon catch guideline is met before December 30, 2017. Sturgeon with fork length of no less than 43 inches and no larger than 54 inches may be retained. These regulations are pursuant to Title 32.14 of the Revised Law & Order Code of the Yakama Nation. Authority to enforce these regulations is provided under Section 32.18.07 of the Code. Violations of any of these regulations are punishable under Section 32.18.07 of the Code.
