

## 2. Fish and Wildlife Committee FY 2021 OFFICIAL ACTION

DATE:

May 18, 2021

TOPIC:

Modification of subsistence fishing regulations for the Icicle River.

ACTION REQUESTED: Open weekly Spring Chinook fishing on the Icicle River.

FORMAL ACTION TAKEN: Section II C 2.a of T-64-21 states subsistence fishing opportunity will be assessed throughout the season. Inseason information shows returns to Leavenworth National Fish Hatchery (LNFH) are in excess of broodstock needs. Therefore, the Fish and Wildlife Committee hereby authorizes the modification of the Icicle River subsistence fishing regulations to allow weekly openings on the Icicle River from Noon Thursdays to 6 p.m. Saturdays from May 20 through July 31, 2021. "Double or treble hooks are prohibited". Once LNFH is assured to achieve broodstock goals, the F&W Committee may consider expanding weekly fishing periods by separate Action. All other regulations in section II.C of T-64-21 remain unchanged. Regulations are pursuant to Title 32.14 of the Revised Law & Order Code of the Yakama Nation. Authority to enforce these regulations is provided under Section 32.18.07 of the Code. Violations of any of these regulations are punishable under Section 32.18.07 of the Code.
